Olivier was born and raised in Ivory Coast, Africa and his primary language was French. All speak English fluently. The three Spanish people regularly translate English materials into Spanish for the benefit of their clients.

Wish List

Here are some of the projects we would like to do in the next year if we can raise the money.

\$1,000 would purchase additional software to enhance the office operations. Needed are additional Quickbooks and Microsoft licenses.

\$10,000 would let us translate and publish 1,000 copies of our *Anger Dynamics* course for use in prisons and jails in the US and ministries that may open up to us in Mexico and Peru.

\$25,000 would enable us to expand our part-time office staff to a full-time equivalent (up to two part-time persons working)

How You can help the FIT Office Help You More

- 1. Order certificates and materials online. Use our special forms that insure that we have all the pertinent data to the what-where-and-whens that we need. Order them online under the "Members" tab. No computer? No problem. Call us and we will type in the forms for you.
- 2. Do not send emails concerning FIT business to Don Pratt's personal email. Send it directly to the FIT office at fit@100hour.org. If you send it to the office, the whole office will get it. If you send it to Don Pratt, it slows things down and increases the chances for errors.
- 3. Keep certificate correction requests to a minimum. Corrections are inevitable, but clerical errors that are not our fault are very costly and time consuming. Be aware that inmates sometimes have multiple aliases and spellings of their name.
- 4. Be patient with us about remembering the status of a prior conversation. We receive many things to keep track of in a day and may have research a past conversation before giving you an immediate answer. We are human, too.
- 5. Respect our rules and policies. They are there for a reason and they apply to all. Inconsistencies in policy can cause hard feelings and loss of favor over the misunderstandings they produce.
- 6. Keep your dues and personal information, especially your email address, up-to-date with us. All of us in leadership are expected to do the same. We place a lot of trust in our recognized leaders and we need to keep good records to vouch for you and to provide you with the availability of hundreds of dollars of materials for effective ministry.
